The subject of the contract is the delivery of a system **for forming tips of intravascular balloons** (form of financing: leasing) meeting the following minimum requirements:

- the Necking Machine designed to neck down balloon tubes
- handling of polymers
- cycle time: 10–30 sec per product side
- tube diameter: 0.7–9 mm
- neck down diameter: 0.6– 4 mm
- pneumatically actuated clamps
- service included in the price, working no later than 24 hours from reporting the defect (receipt of the notification), response time up to 7 days (+ waiting time for spare parts, if required)

The Ordering Party will extend the deadline for submitting tenders by the time necessary to introduce changes to tenders, if it is necessary due to the scope of the changes.

The Ordering Party reserves the right to cancel or cancel the inquiry without giving any reason. The possibility of canceling a request for quotation may arise in particular when the price of the best offer exceeds the planned and available funds for the award of the contract.
